He has been with the department for 27 years, prior to the CHP he was in the US Air Force. He lives in the Antelope Valley.</li> <li>• Antelope Valley CHP is a medium-sized office. In 2026 has to put together as part of his leadership he has set some objects/goals to 10% reduction in fatalities in 1400 sq mile 47 fatal accidents. Want to increase DUI by 5%, increase the amount of times they can have special enforcement details on the road by 60%, speed enforcement by 10% and seatbelt enforcement by 15%.</li> <li>• The AV CHP currently has 49 officers, 42 officers, five (5) Sergeants, one (1) Lieutenant, and himself. Focus on DUI, speed, seatbelts, etc.</li> <li>• Stats: For a 12 month time (January, 2025 – January, 2026) from Avenue T to County line wrote 824 moving violations and over 200 correction violations, with 14 people arrested, 13 for DUI.
