6. Updates	Cal Trans – Highway 138: Drain Project Shoulder Widening Traffic Signal Association of Rural Town Councils (ARTC) – Jose C. Ducktoberfest 50 th Duck Races Cal Trans – Highway 138: Cal Trans – Highway 138: Drain Project – V ditches have been backfilled as a temporary fix. They had to fix them due to code violations. They are going to be redoing them with box culverts with a lid so we will have a wide sidewalk. Shoulder Widening – needed to widen it to allow for traffic safety. No drains on the street which is where the water is coming down. Adding drains on the outside edge and the culvert will all be interconnected to avoid water on the Highway – Expanding from 8 feet to 12 feet. They tried to get the right hand turn lane by 121 st Street but not sure that is going to happy but looking into a workaround. Construction should start just after they complete the signal and should be wrapped up by 03/2026 Traffic Signal – going up probably have beams over the highway tomorrow. Association of Rural Town Councils (ARTC) – Jose C. Special guest Mary J. gave updates at the ARTC Other rural communities were not aware of the SVP system and how it could spread to their areas. Solar /battery storage projects have three (3) new sites, two (2) near Lake Los Angeles and one (1) near the islands of Lancaster.
